Gag-Ordered No More: The 800-Pound Gorilla in the U.S. Government.

Biography: Dr. Brian Czech is the executive director of the Center for the Advancement of the Steady State Economy, which he founded in 2003. From 1999-2017, Czech served in the headquarters of the U.S. Fish and Wildlife Service. During most of that time (2001-2015), he was also a visiting professor at Virginia Tech. Czech is the author of four books, the latest being *Gag-Ordered No More: The 800-Pound Gorilla in the U.S. Government*.

Description: Brian Czech was the first "Conservation Biologist" (by that title) in the history of the U.S. Fish and Wildlife Service. He brought to FWS headquarters field experience, academic achievement, and a specialty in the conflict between economic growth and environmental protection. The latter was welcomed at first, but eventually the gag orders came, and a promising prospect for raising public awareness of limits to growth was destroyed. Czech's new book (and the CACOR talk) is a story about the 800-pound gorilla of economic growth, erosion of First Amendment rights in civil service, and a vision for conservation agencies going forward.

The presentation will be followed by a conversation, questions, & observations from the participants.







- "Conservation Biologist"
- "...serve as the focal point for major management, legislative, and regulatory activities related to the Refuge System."
- "...lead in developing national goals and evaluating key refuge programs."
- "...current knowledge of conservation biology...emerging national priorities and developing critical issues."





Chapter 2. Did Not Say

- "Critical issues may not include the 800-pound gorilla of economic growth."
- "Incumbent will be gagged if attempting to apply the principles of ecological economics."







Chapter 3. A Tale of Two Briefings

- Briefing #1, 1999, fundamental conflict between economic growth and wildlife conservation
 - "This has been the most intellectually stimulating briefing we've had!"
 - "Come back and tell us what we can do about this."
- Briefing #2, 2000, program for raising awareness of the conflict
 - "This is certainly a challenging issue."
 - "I'll put you in touch with our speechwriter..."

Chapter 4. Non-Privy Presidents

- Cabinet meeting
- Focus on growth-rate slowdown
- Commerce, Energy asked to opine
- EPA asked to respond, then others
- Secretary of the Interior rises to occasion
 - 800-pound gorilla
 - Cites FWS Director et al.
- President goes away with new thoughts
 - Eschews the win-win rhetoric
 - Leads toward a 21st century paradigm shift

Disciplinary Action and Abuse of Authority

- Seven gag orders (2000-2017)
- Five letters of reprimand
- Four suspensions
- Relocation to "the closet" (twice)
- Change of position; narrowing of duties
- Network shredding and career blockage





Reasons for Suppression (from least to most corruption)

- Ignorance of ecological economics (all)
- Unwillingness to deal with big-picture, long-term issues (most chiefs)
- Cliquish approach to hiring (Dirth)
- Political aspirations (Crasche)
- Protection of highly privileged, fairly lucrative Refuge System lifestyles (Pudert, Martinis, Lyze, et al.)








- Decreasingly solved, and now #5
